Gloucestershire County Council, as traffic authority, has made an Order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the B4079 Pamington Road, Pamington from its junction with the A46 to its junction with Pamington Lane for a distance of approximately 700 metres.

The reason for the said closure is for Bridge Maintenance Scheme Works.

The said road is expected to be closed from **16<sup>th</sup> July 2025 to 6<sup>th</sup> August 2025** or until the works have been completed. **GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY ROAD CLOSURE**  
**B4079 PAMINGTON ROAD, PAMINGTON (ASHCHURCH RURAL PARISH) (TEWKESBURY**  
**BOROUGH) ORDER 2025**

WHEREAS Gloucestershire County Council ("the Council") being the Traffic Authority for the B4079 Pamington Road, Pamington from its junction with the A46 to its junction with Pamington Lane for a distance of approximately 700 metres ("the Road") is satisfied that use of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road;
2. Nothing in Article 1 above shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
3. Nothing in Article 1 above shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
4. The Road falls within Ashchurch Rural Parish in the Tewkesbury Borough and in the County of Gloucestershire;
5. This Order shall come into operation on the 16<sup>th</sup> day of July Two Thousand and Twenty Five and shall continue in force for a period not exceeding eighteen months or until the said works have been completed whichever is earlier;
6. This Order may be cited as "Gloucestershire County Council Temporary Road Closure B4079 Pamington Road, Pamington (Ashchurch Rural Parish)(Tewkesbury Borough) Order 2025"
7. In the event of any inconsistency or ambiguity between the content of this Temporary Order and any existing permanent/experimental Order(s) imposing restriction(s) on the Road or any diversion routes the latter will be suspended for the duration of the said works and the provisions of this Temporary Order shall prevail during that period.
