



**TEMPORARY CLOSURE OF PUBLIC FOOTPATHS ANW 6 AND AAS 22
(NORTHWAY AND ASHCHURCH PARISHES) TEWKESBURY BOROUGH**

NOTICE is hereby given that Gloucestershire County Council, as traffic authority, has made an Order to close temporarily under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984 (as amended) part of Public Footpath ANW 6 from its junction with Northway Lane at Ordnance Survey Grid Reference (OSGR) SO 92586/33752 in a generally easterly direction for approximately 60 metres to point B at (OSGR) SO 92632/233769 and continues as Public Footpath AAS 22 for approximately 65 metres to its junction with the footpath running from the A46 to Grange Road at (OSGR) SO 92678/33757 and is shown on the Map by a bold solid black line marked A to B to C.

The said public footpaths fall within Northway and Ashchurch Parishes in the Tewkesbury Borough, within the County of Gloucestershire.

The said closures are necessary to safeguard the public whilst bridge works are undertaken.

The said Public Footpaths are expected to be closed **every Saturday night from 9th August 2025 until 11th October 2025 between 22:00hrs and 08:00hrs for a period of 8 weeks** where the presence of approved signage will indicate whether the closure is in force. Further advance warnings of dates/times will be displayed on site 2 weeks prior to any closure taking effect.

Alternative Route – as indicated on the Map by a dash black line.

Emergency access and pedestrian access to adjoining properties will be maintained.

**GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY CLOSURE OF

PARISHES) (TEWKESBURY BOROUGH) ORDER 2025**

WHEREAS Gloucestershire County Council ("the Council") as Traffic Authority under the relevant provisions of Sections 14, 15 and 16 of the Road Traffic Regulation Act 1984 (as amended) is to temporarily close (due to works taking place on or near it) part of Public Footpath ANW 6 from its junction with Northway Lane at Ordnance Survey Grid Reference (OSGR) SO 92586/33752 in a generally easterly direction for approximately 60 metres to point B at (OSGR) SO 92632/233769 and continues as Public Footpath AAS 22 for approximately 65 metres to its junction with the footpath running from the A46 to Grange Road at (OSGR) SO 92678/33757 and is shown on the Map by a bold solid black line marked A to B to C. ("the Footpaths")

NOW THEREFORE the Council in exercise of its relevant powers under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:

CITATION AND COMMENCEMENT

1. This Order shall come into operation on the 9th day of August Two Thousand and Twenty Five and shall continue in force for a period not exceeding six months or until the said works are completed whichever is the earlier;
2. This Order may be cited as the "Gloucestershire County Council Temporary Closure of Public Footpaths ANW 6 and AAS 22 (Northway and Ashchurch Parishes) (Tewkesbury Borough) Order 2025";

GENERAL

3. Except for emergency access and pedestrian access to adjoining properties no person shall proceed on foot, or cause or permit any person to proceed along the Footpaths
4. The Footpaths fall within Northway and Ashchurch Parishes in the Tewkesbury Borough within the County of Gloucestershire.
